Guiding Principles for the FCC Auction Proceeds Strategic Financial Plan

Overarching

- 1. Our students are our core mission and we will focus our resources on their success.
- 2. All FCC auction proceeds activity shall be transparent.

One-Time Expenditures

- 3. SBCCD will use the proceeds as a one-time investment in KVCR for the mandatory transition costs from UHF to VHF over-the-air and current broadcast standards.
- 4. SBCCD will be reimbursed for all costs related to the FCC auction.
- 5. One-time fund proceeds should help KVCR reach financial sustainability within a specified, board-approved timeframe.
- 6. The district unrestricted general fund balance shall be restored to a range of 12-15%.
- 7. With the exception of items 3-6 above, one-time expenditures shall support the approved program review, and educational and facilities master plans.

Principal Investment

- 8. Proceeds shall be invested in a manner that serves SBCCD for years to come.
- 9. Principal amount shall not be used as a resource for ongoing expenditures unless approved by the Board of Trustees.
- 10. Investments should include real estate and a diversified portfolio.

Revenue Generated from Investments

- 11. Revenue generated from the investment of proceeds shall help SBCCD meet its strategic goals as established in the comprehensive master plan.
- 12. Annual revenue amount shall be subject to annual allocation and follow existing collegial consultation and established budget processes.

Subject: Honors Program Coordinator Position

Please receive this memorandum as a request that I might be considered for the position of Honors Program Coordinator. As the Honors Program serves an important function in preparing students for the challenges of rigorous intellectual work, I believe that I am capable in helping them achieve success by assisting the program with the organizational, communication, and procedural demands required of an Honors Program Coordinator. Furthermore, I look forward to working with faculty and staff who share my enthusiasm in helping students identify and accomplish goals of great scholastic achievement.

Entering my third year as an instructor of sociology at San Bernardino Valley College, I am confident that I have demonstrated the capacity to effectively perform the duties and tasks required of this position. As listed in the description for the position of Honors Program Coordinator, please find my responses as evidence for my qualifications.

- 1) Whereas the Honors Program Coordinator is expected to provide guidance and orientation to Honors faculty and work with faculty department chairs to insure the quality and commitment of honors faculty and (11) attend relevant meetings of college groups and committees (department meetings, chair meetings, Curriculum Committee, etc.) for recruitment or curricular matters:
 - I have great working relationships with over half of the faculty teaching honors courses across a variety of disciplines and subject areas. Furthermore, in my work on the Arts, Lectures, & Diversity committee and sub-committee, I have helped the committee chair communicate policies related to funding and requesting speakers to faculty members, both in large meetings and by working directly with individuals. As these qualities stem from my desire to create and implement shared visions of success for our college, I look forward to applying this same process more directly to the Honors Program.
- 2) Whereas the Honors Program Coordinator is expected to oversee honors courses, assisting discipline faculty in creation of new courses and consulting on content review of honors courses:
 - I have experience, at previous institutions, developing courses and working with department chairs to ensure that proposed courses met the UC and CSU Articulation Agreements. At San Bernardino Vally College, I am involved in changes to sociology courses by providing input to the department chair concerning SLOs, course objectives, and requirements. Also, I communicate regularly with my chair about how courses will fit into the medium and long-term goals for the department.
- 3) Whereas the Honors Program Coordinator is expected to manage the Honors Program budget and (8) order graduation medallions (or other forms of regalia accessories, if desired):
 - I have been involved in several positions where I had fiduciary responsibilities related to budget, expenses, and programming, in both long and short-term planning. This includes board membership for non-profit organizations as well as working on the Arts, Lectures, and Diversity Committee at SBVC. In coordinating the John Trudell Poetry annual Reading at SBVC, I had an important role in selecting and ordering the memorial tribute plaque given to the honored poets.
- 4) Whereas the Honors Program Coordinator is expected to coordinate recruitment of students to the honors program:
 - I have in my committee work and position as a faculty member at San Bernardino Valley College developed connections with members of campus that have allowed me to share

events, information, and opportunities to audiences campus-wide as well as to specific sub-groups on campus. More specifically, in coordinating the Battle of the Campuses Poetry Slam, I have been able to recruit a group of students with a very niche skill to represent our college.

5) Whereas the Honors Program Coordinator is expected to act as chair of the Honors Committee, and also (9) chair the Honors Program Scholarship committee, including raising funds for scholarship and chairing committee to consider applications for scholarship;

- I have, in positions outside my role at SBVC, performed various executive duties related to the facilitation of meetings. Most recently, I have been a secretary on a non-profit board, where my preparation of the agenda, minutes, and financial reports were crucial for our meetings. Furthermore, I look forward to using my skills on the Honors Program Scholarship committee, where I have been involved with a community based scholarship program for nearly twenty years. As a part of this program, fundraising and reviewing applicants to receive those funds is a necessary.
- 6) Whereas the Honors Program Coordinator is expected to prepare and manage honors information in various media (update print Program brochure at least yearly, update Program web pages as needed, maintain Program Blackboard community, etc.);
 - I have, for nearly fifteen years, been responsible for managing the media content or community relations of at least one group or organization. This has included, maintaining a presence on social media sites, building and updating websites, and sending press releases. At San Bernardino Valley College, I am working to develop our departmental social media goals and strategies as well as having just recently redesigned our department informational brochure.
- 7) Whereas the Honors Program Coordinator is expected to attend meetings of relevant honors organizations, such as UCLA TAP and the Honors Transfer Council of California;
 - I look forward to attending meetings for the purpose of implementing ideas and strategies
 that will benefit our Honors Program. I also look forward to attending meetings with
 students as a recognition of the work they have done and to help them build a network
 that will facilitate opportunities beyond their time at SBVC.
- 10) Whereas the Honors Program Coordinator is expected to plan and organize workshops, seminars, informational sessions on topics of interest to Honors students;
 - I have at San Bernardino Valley College planned and organized several events. These
 include, the John Trudell Poetry Reading, Battle of the Campuses Poetry Slam, the guest
 lecture of Dr. Juli Grigsby. As a part of the Arts, Lectures, and Diversity committee, I have
 worked with countless other faculty and staff to help develop a range activities including
 lectures, student activities, and information sessions.

With the encouragement of the current Honors Program Coordinator, Honors Program Counselor, and numerous faculty members, I respectfully submit to you this memorandum listing some of the ways my qualifications and experience at SBVC translates into the duties of the Honors Program Coordinator. I look forward to meeting with you and the Academic Senate to convey my interest, my enthusiasm, and my desire to continue serving our students in this capacity.
