Idea for implementation

Advancement in Rank: AP 7210

- Since the AP indicates immediate changes (upon granting of tenure, for example) faculty may start using the title change. A memo should be sent to the Board of Trustees announcing all the advancements to both congratulate faculty and ensure proper recording of the titles.
- All new and current professors with less than four years of experience (aka prior-to-tenure) will immediately upgrade from Instructor to Assistant Professor. They should be informed of this good news regarding titles, business cards, etc.

AIR Idea for implementation

- All professors who have received tenure are automatically conferred with the title of Associate Professor. Some have already achieved this through the prior self-nomination process; the others should now be so informed.
- All professors with three years of experience as Associate Professor may now apply for full Professor status during the call for Advancement in Rank in Fall and Spring?. AP 7210 has as criteria: a) service to department, b) service to college, c) service to community.
- Some recently awarded Associate Professors will not yet have three years at that rank despite having served here the requisite seven years (three with tenure). The open question now is: what to do in these cases? Must they finish the three years at that level, or can they move up now based on their overall level of service? Joe N had requested that they identify themselves so we can get a handle on the scope of the matter.
