Fontanilla</b> <ul style="list-style-type: none"> <li>• I want to give you a little insight into how the board is prepping to come to their meetings. They spend a great deal of time wanting to know what's happening on each of the campuses. Now we have this platform called Cascade... The board comes looking at their goals every month and the question they ask is, how are we fulfilling our core goals that we</li> </ul> </li> </ul>	

		<p>have established? Colleges look into the strategic directions that you put in your educational master plans and your student equity plans. They're looking at goal number two, at the next meeting, which has to do with a lot of the DEI work. We are already starting to work on goal number three for the next month, but they are now getting their training and going into Cascade and looking at what we're doing.</p> <ul style="list-style-type: none"> <li>• The Chancellor will be familiarizing herself with what we're doing. She's going in to review several days before and we're all scrambling to make sure we get everything in Cascade. You will be asked, as you do things, as you work on your initiatives, as you go to trainings, and participate in different events, go to conferences, et cetera, to put that in Cascade. We will be talking about this probably for the rest of our lives because they'll be going in to see what we're doing. This is how they're going to track. If they have questions about anything that's in there, we'll be asked to explain what's going on and to give them a little bit more insight into it. The end goal there is when it's time for accreditation, we open it up and we say, voila, here's all of our work. When it's time to develop a new program, we open it up, we look at our work and it should be there, it should be our history. I think in a lot of ways it's going to be really good for us to be able to track that.</li> <li>• Second, the Inland Empire K-16 Collaborative Grant of \$18 million was awarded to UC, Riverside, to open this RFP process. The purpose of it, of course, is to create pathways for our students to come to college or go into the workforce. We want to be a part of getting some of this money. I think the allocations are up to a million dollars and the collaborations have to be with a K-12 school, a community college, CSU, and UC. The due date is November 17. We are having ideas and conversations about what we want to do, but I think it would be a great opportunity if we were able to get some of that money and use it for our students to create pathways to college and go to the workforce in order to be successful here.</li> <li>• Thank you for your continued support.</li> </ul>
