INFORMATIONAL ITEM: PROFESSOR EMERITUS STATUS TO DR. PETER JOHN STANSKAS

The Academic Senate of San Bernardino Valley College has approved the following resolution and wishes to inform the Board of Trustees:

SP25.01 Conferring Professor Emeritus for Dr. Peter John Stanskas

Whereas, San Bernardino Valley College expresses deep gratitude to Dr. John Stanskas for his unwavering dedication to students, the campus community, and the California Community College System; and

Whereas, Dr. Stanskas earned his Doctorate in Nuclear Chemistry from the University of Maryland and pursued his passion for teaching at San Bernardino Valley College, beginning as an adjunct faculty member in 2001 and becoming a full-time Chemistry faculty member in 2002; and during his tenure, Dr. Stanskas served in numerous leadership roles, including Academic Senate President, Dean of Science, and Vice Chancellor of Academic Affairs, profoundly impacting the lives of students and colleagues; and

Whereas, his contributions extended beyond SBVC, serving as President of the Academic Senate for California Community Colleges, where he championed the interests of faculty and students statewide; and

Whereas, AP 7210 Academic Employees (Academic Rank) authorizes the conferral of Professor Emeritus status to retiring faculty with a minimum of 10 years of service upon favorable recommendation by the Committee on Academic Rank and approval by the Academic Senate; and the advancement in academic rank recognizes exceptional service to the college and promotes a culture of dedication to the college community;

Be it therefore resolved, that the Academic Senate of San Bernardino Valley College hereby grants Professor Emeritus status to Dr. John Stanskas in recognition of his outstanding contributions, distinguished service, and lasting impact on San Bernardino Valley College and the California Community College System.

This resolution is accompanied by a memorial statement signed by numerous faculty and staff who wish to honor Dr. Stanskas's legacy.

ELIMINATE BARRIERS TO STUDENT ACCESS AND SUCCESS

I am pleased to report the outstanding success of our recent Grad Check Event, organized and led by Jamie Salyer, whose exceptional leadership made this event possible. The results were impressive: 320 graduation applications were submitted in a single day with a 99.3% satisfaction rate from surveyed students.

The enthusiasm and dedication on display were remarkable. The event featured 32 counselors across multiple departments and numerous Classified Professionals and student workers who assisted with check-in, giveaways, food service, and information booths. Many counselors also stayed well past 7:00 PM to ensure all students received assistance.

While we celebrate this successful event, I must bring to the Board's attention our critical need for additional tenured counseling faculty at SBVC. Tenured counselors provide essential support to our students from entrance to exit, and their specialized expertise is invaluable in helping students navigate complex academic pathways. The high demand we witnessed at the Grad Check Event illustrates the ongoing need for dedicated Counseling faculty who can build long-term relationships with our students and provide consistent guidance throughout their academic journey.

Frank Dunn, our dedicated counselor in General Counseling who also serves as the Rising Scholars counselor, recently participated in a substantial outreach event reaching approximately 150 at-risk students from group homes, foster care, or those with juvenile justice system contact.

This targeted outreach represents an efficient use of resources to connect with vulnerable populations who can benefit significantly from our educational pathways. By investing in these early intervention efforts, we potentially reduce long-term social service costs while increasing future enrollment and student success metrics.

Documentation from this outreach will be incorporated into next year's Rising Scholars budget request, ensuring proper assessment of program outcomes and return on investment.
