1. Call to Order and Welcome	Call to order at 9:05 am.

3. Program Discontinuance	Copy of the Program Discontinuance sent out. Changes made in the program efficacy impact the Discontinuance policy. Can be found on the Academic Senate website. The policy hasn't been used since 2010. Request to have committee members read it for discussion at the next meeting. No official policy for creating programs exists. Several suggestions to think about to rewrite the criteria for program discontinuance. If something goes to full review CTE Advisory Council should be considered in program discontinuance. We need a better definition of program.	

4. SWOT Efficacy Update	The goal and planning tutorial was released on 3/15/23. Mentors should arrange an online meeting or email chain for the peers to discuss how they're doing. Writers should be engaging departments. Data drop workshop today. One more drop is scheduled for 3/31/23. Full drafts should be shared by 4/6/23. Mentors prefer face-to-face vs Zoom meetings with their cohorts. Recommend a couple of times next year.
