1. Handed out and reviewed the approved Program Review Needs list.

- 2. Scott reviewed the Business & Fiscal Services Update: FY 2017-2018 Proposed Budget Revised that had information about the Governor's proposed budget.
- 3. Discussed the District Office Projected Assessment for the colleges in FY 18.
 - a. Scott will send out the whole package of the District Office Expense Budget for FY 18 and the 50% and FON Rule to the committee members.
- 4. Scott informed the committee about how the District is doing with reaching the projected FTES for FY 17.
 - a. CHC projected FTES was 5, 2019, they may reach 4,700.
 - b. SBVC projected FTES was 10,714 and they will meet that goal.
 - c. Since SBVC will meet their FTES goal and CHC will not, SBVC might receive additional funds due to the how the Resource Allocation Model works.
 - d. District Enrollment Management Committee agreed to a 1.5% FTES Growth for FY 18.
- 5. The committee needs to develop guidelines on how to distribute any growth allocations that SBVC might receive.
 - a. What percentage for faculty, supplies, equipment, classified, contracts, utilities, etc.?
 - b. Rick recommended for Student Success grants to pay for the additional funds STEM needs for tutors and SIs since the state is shifting funds from other grants to these grants.
 - c. Do budgets increase across the board if some programs are not spending their funds?
 - i. Rick suggested having Program Review do an evaluation of programs to do a prioritization for budget augmentation. Budget augmentation using Program Review data.
 - ii. Give divisions the budget augmentation for them to distribute as they see necessary.
 - iii. Use the formula from the one time "Shot in the Arm" budget augmentation.
 - iv. SBVC does not want to spend/commit all of their growth funds. Need to come up with percentage/formula for ongoing commitments.
 - d. Rick stated that we do not explore if divisions really need all the funds they receive.
 - i. Use a Zero Based Budget Model Programs needs to justify the amounts they receive.

1. Scott updated the committee on the process and the current stage for SBVC's FY 18 development budget.

2. Scott reviewed various scenarios of growth spending, the 50% and FON law, and FY 18 ongoing budget considerations/emerging identified needs sheet.

- a. As SBVC grows, we could receive additional FTES funds that may not be allocated in the current model.
- b. Need to have a growth model that is flexible for decreasing revenue.
- c. It is still an SBCCD goal to move towards 75% full time faculty/25% adjunct, but ongoing funding will be an issue.
- d. The committee agreed that the growth scenarios presented were rational and recommended to continue moving in that direction.
- e. A wage and compensation study for all classified employees will be done and could influence the budget.
- f. Rick suggested using percentages instead of dollar amounts for the scenarios of growth funding when presenting to broader audiences.

1. Scott updated the committee on SBVC's FY 18 development budget.

- a. Distributed San Bernardino Community College District Multi-Year Forecast.
- b. The Governor's May revised budget may affect FY 18 development budget.
- c. SBVC is a medium size college.
- d. Instructional/Physical Plant Block Grant is being cut 75% for FY 18 compared to FY 17. Some of these funds are going towards the Strong Work Force Program.
- e. SBVC goal for FTES in FY 18 is 11,077 based on a 1.5% growth if we hit 10,900 FTES in FY 17.
- f. SI/Tutoring Center needs additional funds.
 - i. Tracking student hours for when they receive SI or tutoring would bring additional FTES to SBVC and help support the center.
- g. A special committee is establishing guidelines and a strategic plan for the funds the district will receive for the FCC sale of their broadcast frequencies.
- 2. Reviewed the District Enrollment Management and Budget Committee's meeting materials pertaining to enrollment recommendations.
 - a. The chancellor desires for SBVC to hit the State Funded Constrained Growth currently estimated at 2.21% instead of the 1.5% growth we committed too.
 - b. SBVC will need to decide how much of summer FTES to use for FY 17 and what to pull over into FY 18.
