VPI Report	<p><b>Baccalaureate Degree Updates:</b> Dr. Humble provided an update on the Water Resources Management Bachelor of Arts Degree. The application has been submitted; part of the application process involves submitting a substantive change to the ACCJC. This will be submitted today and will be on the agenda for the ACCJC Substantive Change meeting at the end of February. We are now in the phase where we are waiting to hear back from the State Chancellor's Office and the ACCJC. Dr. Humble is anticipating hearing back by April or May. Dr. Todd Heibel reminded the Committee that though we submitted the Bachelor's Degree application, there is still room for open dialogue moving through the process.</p> <p><b>Meta Updates:</b> We are in full implementation of CurrIQunet Meta for curriculum and are very close to implementing the Outcomes/Assessment and Program Review modules.</p> <p><b>Enrollment:</b> Our semester enrollments are up 8.5% from a year ago today.
