New Business	<p><b>Updating SPAN 101's SLOs:</b> The Modern Languages department is requesting to update the SLOs for SPAN 101. This course was approved last year with a Fall 2023 effective date and they would like to update the SLOs to the following:</p> <ol style="list-style-type: none"> <li>1. Produce a one to two-paragraph written descriptive passage in Spanish in the present tenses.</li> <li>2. Produce a three to five-minute oral presentation in Spanish in the present tense.</li> <li>3. Use reading comprehension skills in present and preterit tenses.</li> <li>4. Use listening comprehension skills in the present and preterit tenses.</li> <li>5. Recognize and demonstrate a sensitivity to the linguistic and cultural diversity of Spanish-speaking countries.</li> </ol> <p><b>CD 111 Updates:</b> At our last Curriculum Committee meeting, we approved CD 111 to include a lab component. After researching the requirements for CSUSB, the department has decided to remove the lab component to this course and replace it with 15 hours of observation written in the course description. This will more closely align the course to the C-ID and to CSUSB.</p>
