Dear Dr. Thayer and Ms. Simental:

This letter is formal notification of the action taken by the Accreditation Commission for Education in Nursing (ACEN) at its meeting in March 2022. The Board of Commissioners granted continuing accreditation with conditions for two years to the associate nursing program and requested that a Follow-Up Report be submitted by October 15, 2023, as the program is in non-compliance with Standard 4 Curriculum and Standard 6 Outcomes. If the Board grants continuing accreditation following the review of the Follow-Up Report, the next evaluation visit will be scheduled for Fall 2029. Please see ACEN Policy #9 Disclosure of Information About an Accredited Program for the required disclosure statement regarding this decision that must be made to all current and prospective students within seven business days of this letter.

Deliberations centered on the materials available to the Board from this accreditation review process and the recommendation for accreditation proposed by the peer evaluators on the site visit team and the Evaluation Review Panel.

The Board identified the following:

Evidence of Non-Compliance

Standard 4 Curriculum, Criteria 4.2 and 4.7

- There is a lack of evidence that the end-of-program student learning outcomes are used to organize the curriculum, guide the delivery of instruction, and direct learning activities.
- There is a lack of evidence that there is progression in the course student learning outcomes/course objectives throughout the curriculum in support of the end-of-program student learning outcomes.
- There is a lack of evidence that evaluation methodologies measure the achievement of the end-of-program student learning outcomes.

Standard 6 Outcomes, Criterion 6.1

 There is a lack of evidence that there is ongoing assessment of the extent to which students attain the end-of-program student learning outcomes.



Evidence of Non-Compliance (continued)

Standard 6 Outcomes, Criterion 6.1

There is a lack of evidence that assessment data are consistently analyzed and used in program
decision-making for the maintenance and improvement of students' attainment of the end-ofprogram student learning outcomes.

Areas Needing Development

Standard I Mission and Administrative Capacity, Criterion 1.3

• Ensure that data from the assessment of end-of-program student learning outcomes are shared with the communities of interest.

Standard 2 Faculty and Staff, Criteria 2.1, 2.2, and 2.6

- Ensure that all full-time faculty health requirements are current.
- Ensure that all part-time faculty health requirements are current.
- Ensure the faculty maintain expertise in their areas of responsibility and their performance reflects scholarship.

Standard 3 Students, Criterion 3.5

 Ensure student health records are maintained in compliance with the policies of the governing organization and state and federal guidelines.

Standard 6 Outcomes, Criteria 6.3 and 6.4

- Ensure the assessment method (calculation) for program completion includes all students who begin on the first day of the first nursing course for each program option and complete the program option on time.
- Ensure the assessment methods for job placement result in meaningful data and make attempts to contact all graduates.

A Follow-Up Report requires the nursing program to demonstrate compliance with all Criteria in only the Standard(s) with which the program was found to be in non-compliance. The Follow-Up Report for the associate nursing program is to address Standard 4 Curriculum and Standard 6 Outcomes.

Please note that ACEN policy stipulates that a nursing program must demonstrate compliance within a maximum of two years after being placed on continuing accreditation with conditions by the Board. If compliance is not evident at the end of the maximum two-year monitoring period, the program must be denied continuing accreditation and removed from the list of accredited programs, unless the program can make its case for continuing accreditation for good cause. Please refer to ACEN Policy #4 Types of Commission Actions for additional information.

In closing, the ACEN commends the flexibility, courage, and resiliency demonstrated by nursing program faculty and leaders, and their institutional colleagues during the global pandemic.
