

Transitioning from Special Education to San Bernardino Valley College (SBVC)

Making the transition from high school to college is an exciting and important step, and it is natural to have questions along the way. At San Bernardino Valley College (SBVC), the Student Accessibility Services (SAS) team is here to help you succeed by ensuring you understand your rights and responsibilities. If you have a verified disability, you may be eligible for support under laws such as Section 504 and 508 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act (ADA) of 1990, as well as Title V regulations. These laws and regulations are designed to provide equal opportunities for students with disabilities. The Individuals with Disabilities Education Act (IDEA) which guaranteed high school students with disabilities access to free appropriate public education is not applicable in college. To help you navigate this transition smoothly, here are some key things to know:

1. Academic Standards Remain Consistent

College courses and programs maintain their fundamental requirements for all students. While accommodations can provide support, they do not include changes to grading standards or course requirements.

2. The Difference Between High School and College Accommodations

Your high school Individualized Education Plan (IEP) or 504 Plan provide a record of your academic accommodations. These may be informative but are not determinative as to the accommodations you will receive in college. You and your SAS counselor will determine your academic accommodations through an ongoing and collaborative conversation. These accommodations will be listed on your Academic Accommodations Plan (AAP).

3. Take the Lead in Communicating

In college, the student will take an active role in self-advocacy. It is your responsibility to communicate with your instructors about any accommodations you intend to utilize. The SAS Office is here to support you and may advise you on how to initiate these conversations.

4. Meeting Requirements

To enroll in courses or programs, you will need to meet the same prerequisites, such as minimum GPA or completion of prerequisites, as other students. These requirements ensure you are prepared for success.

5. Request Accommodations Early

Planning ahead is key. Be sure to request academic accommodations well before you need them. This ensures everything is in place when classes begin.

6. Follow the Standards of Student Conduct (BP 5500; AP 5500: *see links below)

Being a part of the SBVC community means respecting the Standards of Student Conduct. This helps create a positive and inclusive environment for everyone. All students must adhere to the Standards of Student Conduct regardless of disability, diagnosis, symptomology, and/or side effects of medication.

7. Personal Assistance Is Your Responsibility

If you need help with personal tasks like eating, toileting, or ensuring safety, then it is your responsibility to arrange for a Personal Attendant (PA). Sponsoring agencies such as Inland Regional Center and the Department of Rehabilitation may be able to fund the cost of a PA.

8. Your Privacy Is Protected

Your information is safe with us. The SAS Office follows the Family Educational Rights and Privacy Act (FERPA) guidelines to maintain the confidentiality of your academic records.
