We appreciate your continued interest in the program and membership on the Advisory Committee!

Our Program Goals for 2013-2014:

To continue submission of program documents for the American Library Association's Library Support Staff Certification (LSSC). **Our program received approval for two of their competencies: Access Services and Catalog & Classification.** Our most recent submission is for Foundation Competency—we are awaiting approval.

To maintain course Core Competencies and to continue evaluation and/or updates to our Student Learning Outcomes (SLOs)

 1. ALA (LSS Certificate) update
 - a. Catalog and Classification Competency: Approved
 - b. Access Services Competency: Approved
 - c. Foundations Competency: Pending

2. Fourteen Library Technology Certificates were awarded in 2012-2013!

- a. We have successfully developed and evaluated program level Student Learning Outcomes (SLOs)
- b. Both student retention and success are rising.
- c. Online enrollment to the program has remained steady over the past 3-years at 71%.
- d. Five degrees in Library Technology were awarded 2012-2013!

II. Curriculum Update for Library Technology Program

1. LIB 062, Care & Repair and LIB 067 Library Technical Services: These are the only two classes that are not offered online due to their content and student requests for on-campus offerings. We are recommending that LIB 067 be offered in the spring (rather than fall) and on Saturdays just after the LIB 062 class. This would enable students to only be on-campus once per week rather than, potentially, twice a week.
2. Combine LIB 069, Library Automation for Library Technicians and LIB 068, Library Media Services and increase from 3 units to 4 units. Librarians will assist Celia to do this task as her schedule is busy with her reassignment to accreditation. **Goal: To offer this merged class fall 2015.**
3. Marie will update the outline for LIB 065, Public Services for Library Technicians this semester, fall 2013.
4. Marie will update the outline for LIB 066, Acquisitions for Library Technicians, spring 2014.
5. LIB 064, Introduction to Libraries for Library Technicians: It is recommend by Steve Voisard who teaches this class, and the other librarians, that the content warrants an increase to the units from 1 to 3.
6. Campus discussion is occurring regarding CTE programs and 2-year mini review cycle of which we will be a part of.
 - a. Copy of email is at Reference with attachment of sample mini review document to fulfill 2-year review cycle.

b. Librarians are to sign-off or make suggestions that we'll gather and forward by Nov. 15.
